*** No USEF/USDF membership or horse ID required if entered in Opportunity classes. Horses entered in Opportunity classes are exempt from USEF and USDF membership requirements. Rider/Horses in opportunity classes cannot cross-enter into other recognized classes.

LEVELS: Training Level Through Grand Prix. USEF Opportunity classes at Training Level and First Level classes are run in order.

AWARDS: Six ribbons in each class awarded.

ENTRIES: LAR accepts hard copy entries; entries are processed according to postmark date. Make checks payable to LAR. Entries must include:

Negative Coggins within 36 months for in state horses; within 12 months for out of state horses, documentation of Rhino/Flu within 6 months.

Full payment including class fees and other fees.

Copy of USDF and USEF membership cards for horse, rider, owner and trainer.

*No refunds after closing date, including Act of God. Refunds before closing date given less office fee.

TIMES: Tentative times will be posted July 20th on LAR Facebook page. Official show times will be available in the show office. Please check day sheets to confirm correct ride times.

STABLING: Limited Stabling available. Contact Show Secretary. Permanent stalls, 12x12 and some 10x12, all have doors provided.

DIRECTIONS: From North to South: I-95, take Exit 1 onto Industrial Park Road towards ME-112. Left onto Industrial Park Road. Turn right onto ME-112 Buxton Rd. Approximately 2.3 miles on left, turn left onto Balsam Lane. Parking is in large field on the right

FOOTING: One large sand arena (20x60) and one small sand/microfiber indoor and grass ring warm up arena. All classes held in standard size arena.

OTHER: No dogs allowed on grounds the day of the show. Sharps container in managers booth. EMT on grounds. Veterinarian on Call. Farrier on Call. Contact information posted in manager's booth. Protective headgear must be worn at all times while mounted.
